Make-up days:
If a canceled instructional day is rescheduled to comply with I.C. 20-30-2-3 the day or days shall be rescheduled in the following order of preference:

1. If instructional days are needed for make-up, February 20 will be used for a student make-up day. If additional days are needed, the next five work days following the original last instructional student day will be used for additional student make-up days.
2. If additional instructional days are needed in excess of those described above, the administration will make all possible legal appeals to the state for relief.
